EXECUTIVE DIRECTOR'S REPORT

Mr. Barker stated that he recently attended conference sponsored by FEMA and Governor's Office on Homeland Security on Threat Risk and Vulnerability Assessment. The conference tied into the Plumbing Board dealing with safe drinking water and sanitary conditions.

Mr. Barker also attended a roundtable discussion with the Regional Planning Commission in New Orleans sponsored by the Oceanographic and Atmospheric Association. Mr. Barker told the Board that the Association is interested in a Coastal Plumbing Code for the coastal states in light of the recent Hurricanes and natural disasters.

Mr. Barker then stated that the rest of his time recently has been spent on HB 418. HE updated everyone that Representative Thierry sponsored the bill and that Mr. Finley testified and the bill went through committee without opposition. There were questions on the bill once the bill reached the floor so attorney Bob Urann redrafted the bill and the plan is to bring the bill back in the House once the environment is right in the Capital. Mr. Urann explained the bill to the audience and that the reason the bill had to be redrafted was because of questions on the civil fine in Subsection A. That portion was taken out of Subsection A and moved to Subsection B and should satisfy those who had questions. The other portion that brought up concerns was where the money would go. Mr. Urann explained that the money would go back into the operations. Mr. Urann said that the bill is ready to be presented again. This concluded the Executive Director's report.

OLD BUSINESS

The Advisory Board brought up earlier in the meeting about the re-routing/open sewer under a house issue and what the Plumbing Board needed to do. Mr. Finley stated that it really was not a Plumbing Board issue; it was more a DHH issue. Jeremy Harris with DHH said that the re-routing would leave an open system under the slab and would weaken the soil and would be in violation of Subsection 305 under Discharges of the Louisiana Sanitary Code. DHH does not have someone to monitor this and they think that the word needs to get out about this violation. Mr. Finley stated that since it was not a licensing issue that DHH could work to draft a letter or notice to make the Master plumbers aware of this situation.

NEW BUSINESS

a.) Late Continuing Proffessional Education (CPE) Classes-

Mr. Jerry Payne brought up that PHCC would like to have approved a packet that has materials and exam in it, much like Texas has. And those looking to take a late CPE class could come to the Plumbing Board administrative office and take this exam packet and have the staff grade it. Mr. Finley brought up that CPE is supposed to be put on by providers and not staff. Computer based make up classes was discussed but the issue is not knowing who is on the computer taking the course. Mr. Urann stated that legally the Plumbing Board couldn't take on a cooperative agreement with providers to assist in the make-up classes. The Board will monitor this and discuss it further at another time.

b.) Apprenticeship Program-

Mr. Jerry Payne asked that the staff draft a letter to have a mailout about new apprenticeship requirements for 2012. It was discussed that it is already in the works to add this to renewal forms and place on the website as well. Mr. Payne also asks that the Plumbing Board draft a letter to notify PHCC.
